MODULE AIM

The aim of this module is to deepen students' research skills so that they are able to develop a well thought through research proposal supported by a preliminary literature review and proceed to conduct their own research project or study, at a level appropriate for a postgraduate award, in a way that demonstrates reflective learning.

MODULE LEARNING OUTCOMES

By engaging successfully with this module a student will be able to

- formulate, develop and evaluate a research topic through reflective learning that demonstrates critical understanding of methodological issues and the relevance of published research for the research topic.
- 2. prepare a detailed research proposal supported by a preliminary review of the relevant academic literature;
- 3. reflect on its implications of producing a detailed research proposal for your future professional development.

INDICATIVE CONTENT

This particular module will be informed by the material covered in the earlier Methods of Enquiry: Research and Consultancy in Finance Module. The content will be focussed on putting together a research proposal and the learning resources used will be similar to those outlined in the Methods of Enquiry: Research and Consultancy in Finance Module.

LEARNING, TEACHING AND ASSESSMENT - STRATEGY AND METHODS

Students will be supported in their learning, to achieve the above outcomes, in the following ways

The learning philosophy adopted is fundamentally enquiry based and through it students are encouraged and supported to take a critical and independent approach towards the anticipated learning outcomes.

There will be initial inputs by the module team through a serious of workshops in which keynote ideas and themes will be introduced. In addition, students will receive several one to one guidance meetings with the module tutors and their dissertation supervisor to support the development of their

capability to undertake research as demonstrated through the completion of an individual Research Methods Workbook.

The Workbook, issued following the initial workshop sessions, contains a sequence of separately specified tasks relating to the selection, justification and development of a research proposal, detailed literature review and critique, as well as reflection on the implications of the research process for future career development. The Workbook comprises a portfolio of activities undertaken in preparation for the final dissertation. The several elements of the workbook have separately specified completion dates so that the completed Workbook logs progress from the initial idea for a possible research topic, the literature search and review, through to the completion of the introduction chapter of the final dissertation. It also contains the University's Research Ethics Form that students complete in conjunction with their dissertation supervisor after they have finalised their research proposal. Each element within the Workbook has a deadline for completion and the first three elements have to be agreed and signed-off by a member of the module team. The sequencing of the elements in the Workbook extends across the whole delivery period of the module and is dovetailed to support the group presentations within the module. The student's final choice of research topic articulated as one element of the Workbook is also used to facilitate the allocation of an appropriate dissertation supervisor.

Students will be required to make non-assessed group presentations, as well as assessed group presentations, to their peers during the delivery of the module and will receive immediate feedback on their presentations to assist their learning. The group work and presentations are structured to serve as vehicles to stimulate students to interact and reflect on the nature of research activity, the purpose and structure of a research proposal and the use of alternative research methodologies.

ASSESSMENT TASK INFORMATION

The degree of attainment of the learning outcomes for the module will be assessed on the basis of coursework. Student progress will be assessed via the use of two coursework tasks:

- 1. The first task is a group presentation of a detailed research proposal based on an assigned research topic, (25%) (This will be assessed on first two assessment criteria detailed in the grid below).
- 2. The second task is a written individual Research Methods Workbook, (75%). (This will be assessed on all three of the assessment criteria detailed in the grid below).

The Research Methods Workbook will be issued at the commencement of the Research Methods module and completed in stages as the module progresses. The Research Methods Workbook will:

- present a statement of the focus of the research and the main questions to be investigated;
- theoretically contextualise the topic through a review of the relevant literature;
- from the above, either articulate the hypotheses to be deductively tested through the collection of data, or articulate the concepts/embedded problems that are going to explored by other means;
- critically review the research methods available for undertaking the proposed research and justify the choice of method to be used;
- discusses the practical outcomes of the research and demonstrates an achievable research plan.

The detailed proposal presented in the Workbook will form the introduction to the final dissertation. The Workbook will also contain a critical review of three key published research articles/reports/monographs directly relevant to the proposed topic of research. This preliminary literature review will form the basis for the literature review section of the final dissertation.

FEEDBACK

Students will receive feedback on their performance in the following ways

The Research Methods Workbook is structured in such a way as to provide students with ongoing individual face to face formative feedback on their progress, with either a member of the module team or their dissertation supervisor, prior to completing their Workbook as the final summative assessment task. The module leader will provide written feedback on the completed Workbook within three weeks of the submission deadline.

Formative guidance on the skills required to develop successfully a research proposal will be provided through tutor and peer evaluation of student led seminars which take place during the delivery of the module. There will be immediate informal feedback on the group presentations by the module team to the students which can then be used to inform continued work on their research proposal in their Workbook.
