1 MODULE AIMS

The dissertation provides an opportunity to work in depth on a topic in the field of human resource Management for students choosing the MSc in HRM. The dissertation is the culmination of the masters programme and it offers students the opportunity to enhance their personal and professional development through an in-depth independent study in an area of their choice that is relevant to Human Resource Management. The dissertation aims to develop student autonomy, together with the academic and professional skills to design and conduct a rigorous piece of research.

3 INDICATIVE LEARNING, TEACHING AND ASSESSMENT ACTIVITIES

The learning philosophy adopted will encourage students to take a critical and independent approach towards the anticipated learning outcomes. To achieve this students will:

- meet with an appointed academic supervisor to discuss the research, seek advice on methodological issues and background reading, and as necessary, on the appropriate method of presentation.
- work independently conducting empirical research and a review of the OB/HRM literature.
- as an HRM practitioner to be encouraged to reflect upon the process of research

The dissertation is 15,000- 20,000 words. Formative feedback will be given by the supervisor during the supervision meetings and/or in writing. Summative feedback will be given after the dissertation has been assessed by the student's supervisor and a second marker.

4 INDICATIVE MODULE CONTENTS / TOPICS

We are not overly prescriptive about the focus of the dissertation, but we do encourage research work that enables students to critically assess and analyse the options for developing & managing people in a given context. We also welcome research which explores the impact of organisational or societal change. The dissertation should be issue centred, in which a transferable HRM issue of interest or concern to organisations is researched, such that conclusions of specific and general applicability can be drawn. The research will usually be based on both secondary and primary data.

The theoretical and literature base will depend on the topic selected, but this is likely to build upon the material and approaches covered in the taught part of the programme which address specific areas of HRM.

The dissertation utilises all of the indicative module contents of the Research Methodology module
